- Rockland:** Pick-up on Sundays between 11am and 12pm at the First Universalist Church in Rockland located at 345 Broadway
- Rockport:** Pick-up on Sundays between 1pm and 2pm at Farmers Fare located at the corner of Route 90 and Cross St
- Belfast:** Pick-up on Sundays between 3pm and 4pm at the Belfast Food Cooperative located at 123 High Street
- Bangor/Orono:** Pick-up time and location to be announced as soon as we reach the 40 subscribers needed to make this delivery feasible!

9) Please read and initial the following CSF subscription guidelines:

Please bring a cooler to pick up your share each week. Customers who are unable to pick up their shares in a given week must notify the cooperative at least 48 hours before the scheduled pick-up time. We offer two options for these circumstances:

- 1) Receive a double share of shrimp the next week
- 2) Donate your missed share to the Share to Spare program, which provides fresh seafood each week to the Rockland-area food pantry and Meals on Wheels programs.

Customers are responsible for picking up their shares at their specified pick-up location and time each week unless they have notified the cooperative that they will not be able to do so at least 48 hours previously. Shares that are left at the end of a CSF pickup will be forfeited by the customer, and donated to a local food pantry or Meals on Wheels program. Missed share deliveries due to weather-related impacts on fishing are the cooperative's responsibility and will be rescheduled for future weeks.
